ADDITIONAL CONSIDERATIONS FOR FIRE SUPPRESSION SYSTEM:

1. **GAS:** If you have gas appliances the code requires that they shutoff automatically in case of fire system activation. If indicated in the Estimate & Agreement we will furnish the gas valve itself and connect it to the Ansul control. You will be responsible for having the gas valve installed in the gas line.
2. **ELECTRIC:** If you have electrical appliances needing automatic shutdown as required by code, we will furnish electrical contacts if indicated in the Estimate & Agreement. Wiring and contactors are not included unless specifically quoted.
3. **HOOD AND DUCT:** We have not reviewed the hood and duct system for code compliance. It is suggested that you have a competent sheet metal company review the hood and duct installation for code compliance before fire system installation.
4. **LIQUID SYSTEMS:** The tanks on liquid fire systems need to be protected from freezing.
5. **FIRE EXTINGUISHERS:** The fire code requires that a portable extinguisher with a class K rating be in the kitchen.
6. **INSPECTION CONTRACT:** The fire suppression system is designed to meet the latest NFPA and State fire codes. In order to maintain fire code and insurance credit you will need a semi-annual inspection contract. Inspection contracts are subject to annual review and adjustments based on current labor rates.
7. **TEST:** At completion of installation a functional test recommended by the manufacturer will be performed. Quote does not include a puff or discharge test.
 - 1) Terms: Net 10 unless proper credit application is filled out and returned to our office.
 - 2) May be subject to N.Y. State sales tax or a tax-exempt certificate will be necessary.
 - 3) Proposal based on work being performed during normal business hours.
